In the last year, Caledonia Home Health and Hospice was honored to provide 14,431 visits to the town residents of Lyndon, VT. Our staff visited 233 homes of community members living in the Lyndon area.

While working with residents, we provided physical, occupational, and speech therapies. We provided skilled nursing, medical social work, personal care attendants, and even home makers. We work together with primary care physicians so that care is specific and structured to treatment goals.

### 2015 report to the Town of Lyndon:

The Lyndon Area Meal Site is a non-profit organization governed by a board of twelve members. The mission of the Site is to provide hot nutritionally balanced meals to eligible seniors, persons with disabilities and residents in need at a dramatically subsidized, affordable cost to them. We also serve the general public noontime meals reasonably priced. The dining room at the Darling inn offers patrons a congenial area for socialization, entertainment (with several local individuals volunteering their musical talents), and special events. It is staffed by two part-time employees who serve Monday through Friday noontime meals.

Anyone is welcome, regardless of age or need. The meal site serves between 300-400 meals a month in the dining room. A larger part of the service that Lyndon Area Meal Site provides is the Meals-On-Wheels program. Close to 2000 hot, nutritious meals are delivered monthly to homebound community members. Many volunteers contribute to keep the programs and services going but we continue to rely heavily on donations, fundraising and appropriations.

Some of our funding comes from AAA (50%), meal reimbursements (18%) and VCIL (less than 5%). Diners contribute what they can afford but to balance our budget we need support through our annual appeal letters, coin drop and local friends and citizens. Town appropriations provide crucial funds necessary to allow us to continue our mission. We are finding it more difficult every year to balance our budget as we try to absorb the ever rising cost of food and supplies.

So, in appreciation for the services of our senior citizens and all other clients who rely on this meal service, the Lyndon Area Meal Site and Meals-On-Wheels respectfully requests an appropriation of \$4000 from the Town of Lyndon for FY 2016. Thank you in advance for your continued consideration.

The Board of Directors of the Lyndon Outing Club (LOC) wish to thank you for your generous and continued support. We have worked hard over the past year to make some required improvements to the lodge and equipment.

- \* Tee Bar We were required to reline the bull wheel, top and bottom, this year in order to pass inspection. Our board members worked diligently to find the needed materials to make sure the reline was done right. We believe this reline will last another 50 years.
- Partnership with Lyndon State College Our partnership with Lyndon State College (LSC) continues to expand. LSC students continue to partner with us for community service days, trail maintenance, lift operation, hosting classes, and more. LSC students have been pivotal in staffing events and helping to create new events every year.
- Lodge This year, our aging electrical systems finally gave out and needed replacement. Money that had been saved for renovations was diverted and our electrical systems received a full upgrade thanks to the efforts of former director, Roland Clifford. We also have been working to bring the basement up to a more useable standard and hope to renovate the bathrooms this spring to make them more modern and fully accessible. We continue to receive requests for rentals for family get togethers, wedding receptions, class reunions, trainings, and office gatherings.
- \* Snowflake Festival We continue to offer free or low-cost events during the annual Snowflake Festival. Our family night hosted more than 100 families in February 2015! It was great to see lines at the lift and have young and old alike skiing, cooking hot dogs over the fire, and enjoying music in the lodge. We plan to add even more events in 2016 as our board grows and we open up some summer and fall events.
- \* Four Seasons The LOC has seen tremendous increase in the off season use of the hill. Three local fitness programs are using the hill on a weekly basis from spring through fall; hikers use the hill daily; the skate park sees ongoing use from local and out of towners; and we have partnered for several special events including a spring hill climb, obstacle course race, pre-season rail Jam and music festival.
- ₱ Sledding Based on our community survey, we are now offering sledding to schools at a reduced price during the school days so that schools who cannot afford ever-increasing ski rates can add a more affordable outdoor option to their winter sports programs. This was piloted with one school in 2015 and will be offered to up to five schools in 2016, first-come, first-served.

In 2016, we will celebrate our **80<sup>th</sup> anniversary**. Although winter has changed, and we have had to change with it, our volunteer board members are committed to providing quality, affordable outdoor recreation opportunities for our community. ### Town Report Summary

#### 2015 NEKYS Served 625 in Lyndon

NEKYS has been offering vital supportive services for youth and families since 1975 In 2014 NEKYS served 3088 individuals throughout Caledonia and Essex Counties

### NEKYS Family Programs Provide:

- Staff is available 24 hours/7days a week to support families through periods of crisis and conflict.
- Supportive counseling for youth and families, case management, support for youth and families within their schools, and family mediation.
- Outdoor adventure opportunities that include kayaking, canoeing, hiking, swimming, and mountain climbing. The group works on learning coping skills and self-care strategies.
- Adult mentors once a week in the school for at-risk students in the 1<sup>st</sup>-8<sup>th</sup> grade. Adult mentors establish supportive relationships that result in improved academic performance and positive life choices.
- Summer Central Calendar and scholarship program so parents know of recreational opportunities for their children and offers scholarships for children to attend summer activities they otherwise could not afford.

### NEKYS Youth Program Include:

- Staff is available 24 hours/7days a week to support families through periods of crisis and conflict.
- Support to local young people ages 15-22 that are homeless or at risk of homelessness; have current or past involvement with foster care; are pregnant and/or parenting; experiencing mental health issues; struggling with substance abuse; have current or past involvement with the criminal justice system.
- Programs that utilize a positive youth development, trauma-informed approach that is tailored to meet the needs
  of young people. Encouragement for each young person is to identify their strengths and achieve goals related to
  housing, education, employment, and life skills.
- Access to short-term and long-term housing support that addresses the complex needs of young adults who are 18-22 years old. Young adults receive support which include in-home case management, rental assistance, landlord mediation, job skill development, and educational advancement support.
- Opportunities for young people ages 15-25 to connect with supportive adults in a safe substance-free environment Monday through Friday from 12-5 pm.
- Connections with positive peers, educational groups that focus on healthy life choices, and opportunity for young people to "give back" through community service.

#### NEKYS Restorative Justice Programs Include:

- A voluntary and confidential alternative to court proceedings for individuals ages 10 through adult.
- Programs based on restorative justice practices that give the person who violates the law the opportunity to identify and repair the harm done to the victim, the community, and themselves.
- Opportunity for the individual who completes the requirements of the program to have his or her case closed in the legal system.
- Help for individuals to regain their driver's license while they pay off their fines and fees.
- Support for 16 to 21 year old youth who are referred to the program after receiving a notice to report from a police officer for possession and/or consumption of alcohol or marijuana.
- Assistance for youth ages 10 through 22 who have been adjudicated in Family Court, are on probation and require additional support by the Department for Children and Families.
- Pretrail Services a new program involving risk assessment and needs screening.

Northeast Kingdom Youth Services is a private, non-profit agency governed by a community-based, volunteer Board of Directors. RCT is a nonprofit corporation providing transportation to the elderly and disabled, Medicaid and general public through a van, bus or volunteer driver service. Last Year between all of our programs, RCT provided over 206,987 rides.

RCT transports people to, adult-day service facilities, senior meal sites and necessary medical treatments such as, dialysis, radiation therapy, chemotherapy, physical therapy, special medical needs and other appointments. ## Report of 2015 Activity for Lyndon Town Appropriation Request: \$ 7500

Umbrella exists to ensure that communities in Caledonia, Orleans and Essex counties offer safety, support and options for self-determination to women and families. To this end, we provide the following services:

The Advocacy Program is the essential safety net for people affected by intimate partner violence and sexual abuse. We meet the needs of victims in crisis while also offering preventative programming to local schools and youth groups with a focus on gender respect, consent, and healthy relationships. In 2015 we:

- supported at least 496 individuals with direct advocacy
- housed 17 adults and 13 children in our shelter for a total of 1578 bed-nights

Kingdom Child Care Connection is the community-based child care resource and referral center for Caledonia and Southern Essex counties. We are responsible for helping families find and pay for high-quality child care services while also increasing the availability and quality of child development services through professional development opportunities and targeted programmatic supports. In 2015 we:

- helped 79 families find high-quality child care at no-cost
- connected 538 families with the Child Care Financial Assistance Program
- supported the creation of 5 new child care programs in our region's most underserved areas
- offered 235 hours of professional development to 88+ child care providers to ensure the people responsible for taking care of our youngest citizens have the tools and resources they need to do their best.

The Family Room is a supervised visitation and monitored exchange center offering child-centered support for parents seeking to establish or rebuild relationships with their children. Last year we offered 1051 hours of visitation to help 105 children develop safe, healthy relationships with their non-residential parent. Additional services such as therapeutic visitation, parenting education, and mediation can also be arranged in order to help families address their unique goals and needs.

Cornucopia is our newest program geared towards helping women-in-transition achieve economic self-sufficiency. This 17-week job-skills training program introduces women to the culinary arts as they prepare Meals-on-Wheels for Newport-area seniors. After completing the program women are assisted with securing employment with a local business, in a position that fits their individual strengths and interests. To date, Cornucopia has provided over 34,000 nutritionally-balanced meals to Newport-area seniors and empowered 12 women through hands-on culinary and hospitality training.

Given that some of our services are provided anonymously, it can be difficult to provide precise usage figures for towns. At least 186 of Lyndon households and 17 child care providers were served directly by Umbrella in 2015, and the community as a whole benefited from prevention and outreach programs at schools, as well as training and consultation for human service and law enforcement professionals. Community support is critical to sustaining our programming and discovering innovative new approaches to the work we do. We are deeply grateful for Lyndon's support.

Powers Park/VIS respectfully requests placement on the appropriations list for Town Meeting on March 1st, 2016. We are again requesting the sum of \$7,500.

2015 was a huge year for us! Our Centennial Celebrations went on throughout the summer and were a lot of fun! Thank you to all our community members who celebrated with us! Thank you also to the many local businesses and citizens whose generous donations helped us reach our fundraising goal of \$25,000 to secure a Land and Water Conservation Fund Grant that will enable us to make several long-overdue repairs to the pool. Prior to opening the pool in 2016, renovations will be done including resurfacing the pool, updating of the bathrooms and adding an ADA-compliant pool lift. We are so excited to invite everyone to our June 2016 Grand Opening!

Last summer we continued our high-quality Red Cross Swim Instruction and USTA Tennis instruction, serving 400 children a day-over half of them from Lyndonville! Our WSI certified pool manager ran a great program-continuing our 6 week Baby/Adult swim class on Saturdays and adding an Adult Lap Swim on Mondays and Wednesdays. We continued providing organized sports every afternoon. Our 2 Upward Bound volunteers helped with that and also running the snack bar. Tom Powers returned to help teach tennis with our assistants. Our Arts and Crafts program continued to create fun projects with the help of a generous Burklyn Arts grant. The Vermont Agency of Education and Hunger Free Vermont lunch site provided lunch to over 180 children a day-this year adding two hot lunches a week! The Bookmobile came 2 times a week. We had three pool party fundraisers, one just for local teens, built an award-winning Stars and Stripes float and won lots of ribbons at 3 swim meets, one of which we hosted with the help of many experienced volunteers and former employees! 12 local daycares/businesses sponsored bistro umbrellas for our picnic tables providing much needed shade to our friends and families watching lessons from the pool deck. Stay and Play daycare bought us signs to help the daycares and families load and unload children safely. Without the support of our local businesses and friends, we would not be able to provide the services to the community that we have for the past 100 years.

With some of the funds from 2015 appropriations, we purchased new instructional tools for the swim classes and swim team and continued to make improvements to the buildings and park-including new electrical wiring for several rooms and updated plumbing. With our \$3000 USTA Renovation Grant we finished the total resurfacing of our two tennis courts, and they look absolutely brand new! Also this year, for the first time ever, our staff and instructors were all able to make minimum wage.

On behalf of the Directors at Powers Park, we again would like to thank all of you for making Powers Park continue to function and succeed.
